



# AN UPDATE FROM FROM OUR CIVIL RIGHTS DIRECTOR









2020 may have changed the way we do business, but it certainly did not change our commitment to civil rights!

The past year brought us so many adjustments. While some of them were hard – office closures, quarantines, and the looming global pandemic – we have also had some time to be more thoughtful and intentional about our work. We reaffirmed our commitment to racial justice with our 5 Point Plan, which informs every aspect of our work at CAIR-OK to address pervasive anti-Blackness in our communities and our country. We worked with allies throughout the community, across the spectrum of social justice advocates, to join the fight for positive change. And we continued our traditions as the state's strongest Muslim civil rights advocacy team, leading our community through a historic election and a cultural revolution which is continuing to unfold.

The Civil Rights Department has remained hard at work, continuing to serve clients and guide people through the many challenges that face Oklahoma's Muslim community. Thanks to technology, we met with a variety of community leaders through the Community Check-in Videos, to get connected to the wonderful work of Oklahoma's many warriors for change. Our seminars on racial justice and religious tolerance helped engage a wide audience as we discussed challenging subjects like intra-community racism, gender justice, and the meaning of representation. We were even able to host Legal Fellows over the summer, who got the opportunity to speak with clients, work at the cutting edge of Constitutional jurisprudence, and grow in their own understanding of civil rights law.

It has been an honor and a pleasure to serve you for the past six years. 2020 was a year of many challenges, but it has also been a year of growth – a chance for us to take a step back, focus on our foundational principles, and reaffirm our commitments to justice for all. We remember every day that where the rights of one person are threatened, the rights of all become less secure, and we work together to secure peace: not the peace that is the absence of conflict, but peace that is found in the presence of justice.



# CIVIL RIGHTS DEPARTMENT

#### **FIVE POINT PLAN FOR RACIAL JUSTICE:**

In 2020, America has been forced to confront our painful history of anti-Black racism – a pattern of thought and behavior from which the American Muslim community is, unfortunately, not immune. The murder of George Floyd sparked a cultural revolution as America wrestles with this dark legacy. We believe at CAIR-OK that we have a responsibility to stand with our Black family and to end racialized injustice wherever it occurs. The Five Point Plan to Combat Racial Injustice informs every level of our work, helping us to understand and address anti-Black racism and transmit new knowledge throughout the organization, our community, and beyond. Pioneered in Oklahoma, the Five Point Plan also became the basis for work done at CAIR chapters nationwide – another example of CAIR-OK's leadership throughout our networks.


#### **HATE CRIME:**

When Jenan Ayesh and her family traveled from Enid to Dallas, TX, to celebrate the New Year, they were expecting a time of fun for their children and enjoyment for them all. However, Jenan instead was the victim of a brutal attack by a stranger – a stranger who targeted her for her hijab and left her with bruises and a concussion. When we heard about the incident, we reached out to provide support to Jenan and her family and to ask her to use our platform to share the real dangers of Islamophobia and the effect it has on the Oklahoma Muslim community, spreading awareness of how hateful propaganda can escalate into hate-filled violent attacks.


#### **ANTI-MUSLIM DISCRIMINATION:**

The Civil Rights Department has continued to accept calls, texts, and emails from clients who face discrimination or anti-Muslim bias. We carefully investigate each call or complaint to determine if evidence of discrimination exists and if the complaint falls within the scope of our department. If it does, we are prepared to support clients through the challenging legal process, including reporting to regulatory bodies such as the EEOC, negotiations at mediations, and even litigation where needed. Where we cannot assist, we have a network of legal service providers that can help solve issues in the areas of family/custody disputes, criminal defense, immigration, and more.

#### FEDERAL WATCHLIST LAWSUIT

CAIR-OK has helped Oklahoma Muslims challenge the unconstitutional federal terrorist watchlist through legal challenges which advanced to federal court in 2020. The No Fly List and other associated watchlists, which have created serious problems for traveling Muslims for years, has been challenged as an unconstitutional violation of American civil liberties. Lawsuits proceeding through the court system have revealed heinous practices that specifically target Muslims and which should be struck down.

Prison/jail complaints increased 70% in 2020

#### **POLICY - ANTI-SPEECH BILL**

2020 saw a wave of bills proceeding through the state legislature, many of which were designed to spark controversy. One such bill was HB 3967, which prevented Oklahoma

businesses from entering into contracts with the state unless they promised not to boycott Israel or its territories. We worked with our allies to protest this anti-speech bill and the threat it poses to the First Amendment. We also connected with legislators who asked probing questions about the real intent behind a bill that would stifle our freedom to protest through legal boycotts. Although the bill was eventually passed, we continue to monitor its effects on the local economy and potentially to sue in order to get it stopped.

#### KYR PROTESTS AND PROTEST SUPPORT

The summer of 2020 brought protests to nearly every major city in the nation, including cities and towns in Oklahoma. As grieving and angry communities took to the streets, it became very clear that many people engaged in protests and demonstrations needed to be informed of their legal rights to protest and how to protect themselves should they encounter law enforcement. We quickly created Know Your Rights Protest cards, which were distributed in the thousands at local demonstrations, to help the community know how to fight for their rights.

#### **COALITION BUILDING**

More than ever, the role of strong coalitions is clear in the world of social justice advocacy. Through our strong partnerships with a variety of organizations, the reach of the Civil Rights Department has extended into many corners of the community we previously have never reached. The Civil Rights Director was featured in a task force aimed at combatting domestic violence in the Asian-American community. Our Native American friends remind us of our presence on stolen land and of the ongoing legacy of colonialism that affects us here as well as our families abroad. Ongoing work with the Black community is vital in our work to end intra-community racism and anti-Blackness. And our interfaith partners are helping us to promote social justice wherever we can extend our reach, including amongst the homeless population, inside prisons and jails, and in every corner of the community where we are needed.

#### "MUSLIM-FREE GUN RANGE"

In 2016, we were alerted to a gun range in Oktaha, Oklahoma, which had posted a sign stating that they were a "Muslim-free" establishment. When Army reservist and civil servant Raja'ee Fatihah went there, they were happy to serve him – until he identified himself as a Muslim, at which point he was asked to leave. We filed suit against the gun range for a violation of the Civil Rights Act, and in 2019 won a victory when the gun range changed their policy to allow Muslims to shoot at their gun range.

#### HIJABI DENIED ENTRANCE TO COURTHOUSE

In Summer 2019, the Tulsa County Sheriff's Department refused to allow a Muslim woman to enter the courthouse without removing her hijab, eventually requiring her to remove her scarf in the parking lot, crouched down between parked cars. We sued the Sheriff's Department and forced them to change their policies to accommodate religious head coverings and train their deputies to respect religious requirements.

This year has been interesting in the most unprecedented of ways. We miss hosting our events where we connect with you all, but I look forward to when we are able to again safely, ensuring everyone's health is protected. However, we connected with everyone through various means in virtual settings on Zoom, Facebook and other social media platforms. We checked in with you every month to see how you are doing and we hosted guest speakers to keep us informed about social issues, the elections, local affairs and more throughout the pandemic. It's a new way to stay in touch and communicate, and although it's not the most ideal way to do so, it is what we had to do to protect each and every one of us.

We hosted dozens of virtual meeting with potential candidates, councilmembers and legislators. On election night, we hosted our first-ever election night watch party where we virtually connected with candidates and friends after the polls closed and received live updates throughout the evening.

None of this would have been possible without the encouragement and motivation that comes from you all. Frankly, I miss planning our events for everyone to enjoy, but I have learned to connect with everyone in many different ways and I am in awe of the amount of support we have received throughout this tumultuous year. It is truly rewarding to be your Community Outreach Director for CAIR-OK.

We want you to know that we are here for you. CAIR-OK will continue to serve this community and work towards its mission for your safety and well-being.

# AN UPDATE FROM THE GOVERNMENT AFFAIRS DIRECTOR

If you're reading this, congratulations, you made it through 2020! What a crazy election year we've had. Thankfully, before the pandemic hit, we were able to hold our 6th Annual Muslim Day at the State Capitol, which brought 200 plus participants, many of them students, to the state capitol building to meet with over a dozen elected officials.

This year, like many other nonprofits and businesses, we had to pivot to working remotely. When the focus of your department is engagement, this poses exceptional challenges. At CAIR-OK, we decided to think outside the box and throw our energy and resources into connecting with the community through providing timely and valuable content.

I hope you had a chance to tune in to our Coffee with the Candidates show we launched in July, where we interviewed candidates running for elected office every Wednesday.

I hope you felt educated and prepared when you filled out your ballot for the primary, runoff, and general elections. This year we developed our most comprehensive guides yet. With the help of many interns and volunteers, we were able to produce a general election guide that covered all State House and Senate races. And we were able to branch out to cover Congress and US Senate races taking place in Oklahoma as well.

Since its establishment in 2018, CAIR-OK's Government Affairs Department has continued to increase civic engagement among the Oklahoma Muslim community by educating and connecting Oklahoma lawmakers with their diverse constituents. I look forward to working with each and every one of you in 2021, inshAllah.

#### **2020 MUSLIM DAY AT THE CAPITOL:**

Muslims celebrated advocacy day without protesters yelling at them or holding signs in their faces as they entered the state Capitol. It was a situation noted more than once during the Sixth Annual Muslim Day at the Capitol. "Love and peace never give up, but hate will eventually be extinguished," said Adam Soltani, executive director of the Council on American-Islamic Relations' Oklahoma chapter. More than 150 people preregistered for the event, including a number of youth in attendance.

#### **COFFEE WITH THE CANDIDATES SHOW**

Live interviews with candidates running for office almost every Wednesday from July 11 - October 7.

#### **ELECTION NIGHT LIVE COVERAGE**

Hosted 3 hours of live election coverage on November 3rd from 8PM - 11PM. Interviewed 11 experts and candidates every 15 minutes as results rolled in.

#### FOUGHT ANTI-SPEECH BILL

A bill filed for the 2020 legislative session sought to exclude private business owners from state markets if their political ideologies don't line up with that of the authors'. House Bill 3967, by Reps. Mark McBride, R-Moore, and Jon Echols, R-Oklahoma City, restricted free speech by excluding business owners from full participation in Oklahoma's economic markets and presented an undue burden of requiring all businesses to submit a written certification stating they are not engaged in the BDS (boycott, divestment, sanctions) movement. The bill identified businesses engaging in the boycott as "unduly risky" to deal with and makes a character judgment stating that their "commercial soundness" is impaired.


