

Strom, Judd(R) Daniels, Julie(R) Permits courts to bar convicted persons from entering districts where their conviction took place until after they have completed the term of their sentence, exceptions provided to allow access to services or programs required for parole.

Olsen, Jim(R) Daniels, Julie(R) Makes performing an abortion that is not deemed medically necessary to preserve the life or prevent irreversible impairment of a major bodily function of the woman, grounds for a physician to lose or have their license suspended.

McCall, Charles(R) Treat, Greg(R)

Creates a State Reserved Powers Unit within the office of the Attorney General to review certain federal actions and provides for \$10MIL in funding from the General Revenue to support the Unit's

Boatman, Jeff(R) Haste, John (F)(R) Creates Maria's Law which requires school districts to include certain instruction on mental health in their curriculum.

Humphrey, Justin J.J.(R) Bullard, David (F)(R)

Prohibits the publishing of personally identifying information of peace officers and public officials with the intent to threaten or

Lawson, Mark(R) Haste, John (F)(R) Establishes standards and requirements for the detention of youth

offenders in adult correctional facilities.

Requires recounts for issues and questions in state elections when margins are within a certain percentage and permits the Governor and Attorney General to request a recount of any state question.

HB 2645 Echols, Jon(R) Bergstrom, Micheal(R) Provides relative to restrictions and permissions related to the carry of firearms, permitting municipalities to designate certain areas as having security rules and adjusting various provisions of

Removes a prohibition in statute on the use of videoconferencing technology in jury trials and trials before judges; EMERGENCY.

Permits the Oklahoma Municipal Power Authority to forgo specific requirements of the Open Meetings Act and keep certain records

Brooks, Michael(D) Newton, Carl(R)
