Pursuing Our Freedoms



"No US citizen should be denied the right to return to his or her own country. Saadiq Long is an Americanborn, U.S. Air force veteran and there is no excuse for denying him the right to visit his terminally ill mother."

In April 2012, Saadiq Long attempted to board a flight from Doha, Qatar to his hometown in Oklahoma. Long, a veteran of the U.S. Air Force, converted to Islam in the 1980s and moved to Qatar to teach English in 2000. Throughout this time abroad, the Oklahoma native maintained close contact with his family in McAlester, Oklahoma, and hoped to return after learning his mother had fallen seriously ill.

After purchasing his ticket, arriving at the airport, and attempting to board the flight, though, Long was blocked from returning to the U.S. For reasons unknown to him, Long had been placed on the U.S. no-fly list, thus barring him from traveling to his own country. Though he has no criminal record and no idea why he would be on the list, when he sought help from the U.S. Embassy and the Department of Homeland Security, Long found answers from neither.

After months of frustration, Long's family contacted CAIR Oklahoma, and in August 2012, CAIR Oklahoma took on Long's case. After reaching out to the FBI, TSA, and DHS, CAIR Oklahoma was finally able to help Long fly back to Oklahoma on November 19, 2012, allowing him to spend the holidays reunited with his family.

The victory was bittersweet, though, as FBI agents continued to harass Long and his family throughout his time in Oklahoma over the holidays, both at his mother's residence and in public with his sister Ava Anderson of Oklahoma City. With the help of CAIR Oklahoma, Long and his family were finally able to find relief after holding a press conference and calling on the local FBI to cease the inappropriate and unnecessary harrasment.

When Long attempted to return to Qatar on February 6, 2013, he was again prohibited from boarding his flight, with TSA officials citing security concerns but providing no definitive answers and leveling no charges. Following another failed attempt to board a flight from Oklahoma City to return to Doha, Qatar, Long was left with little choice but to resort to traveling back to Qatar via Argentina in order to avoid traveling through U.S. airspace. In a five-day long journey, Long traveled via bus and plane from McAlester, Oklahoma to Buenos Aires, Argentina and was finally allowed to fly via Turkish Airlines to Qatar via Istanbul, Turkey. "My family and I want to thank all the individuals at CAIR Oklahoma for shedding light on my challenges, defending my rights as an American citizen, and for all other forms of support you provided," said Saadiq Long upon returning to Qatar, "Continue in the great work that you do to protect the rights of Oklahomans."

Protecting Our Civil Rights

In early October 2012, an Oklahoma Muslim woman was trying to check one more item off her daily to-do list as she walked into Tulsa's Valley National Bank to conduct business. Instead, her errand was cut short, as the bank's security prohibited her from entering while she was wearing a hijab- a symbol of her faith as an American Muslim woman.

She was given two unreasonable and equally demeaning options- remove the hijab or be escorted throughout the establishment by bank security. Humiliated, she rejected both options by choosing to leave the situation and seemingly leave her civil rights as an American at the bank as well. Having recognized the blatant discrimination on behalf of Valley National's policies, she contacted CAIR Oklahoma in order to help resolve a situation that no person of faith wants to encounter while wearing something that represents their religious tradition.

CAIR Oklahoma immediately asked the Tulsa bank to review and revise their policies regarding religious head coverings, not only for Muslims, but also for people of all faith traditions. CAIR Oklahoma took note to emphasize that Valley National had CAIR Oklahoma's full support in upholding the bank's security procedures, but prompted the bank to remove its policy of possible religious discrimination. In the days after the controversial incident, CAIR Oklahoma received the most media coverage since the chapter's inception, which highlights Oklahomans' growing concern for the state's Muslim community.

Following weeks of dialogues between CAIR Oklahoma, various civil rights and interfaith groups, and the Oklahoma Bankers Association, the Oklahoma Bankers Association affirmed the need for Oklahoma banks to accommodate the needs of Oklahomans who choose to wear religious coverings. Many lessons were taught by this dramatic shift in policy, which now ensures inclusivity and fosters religious pluralism. Through CAIR Oklahoma's relentless work, Oklahoma bank employees were not only able to become educated on religious clothing requirements, but they were also encouraged to understand that preserving the dignity of customers from various faiths can be complementary to maintaining bank security. This case highlights the truly diverse community that CAIR Oklahoma serves and should remind those in the majority to remain attentive to the needs of their fellow Oklahomans who are often forgotten. Still, the success of this change in policy, while championed by CAIR Oklahoma, should be shared by all of Oklahoma's interfaith groups and underrepresented citizens, as the preservation of civil rights is a win for all.

Throughout the 2012 election season, CAIR Oklahoma hosted a series of voter registration drives throughout the state at local mosques and community centers, in a series of events entitled *Voice Your Vote*. The aim of *Voice Your Vote* is to empower the Oklahoma Muslim community to get involved and to become more aware, engaged, and represented in the political process.

As part of this campaign to engage, educate, and empower the Oklahoma Muslim community through the election process, CAIR Oklahoma released a guide to voting in Oklahoma. The guide included information on when and where to vote, contacting local Republican and Democratic parties, and what to bring on election day, as well as an informative breakdown of the ballot's state questions and their implications for our state.

CAIR Oklahoma hosted Voice Your Vote events in Oklahoma City, Tulsa, Stillwater, Edmond, and other cities throughout Oklaoma as a part of this campaign. Nationwide, the Voice Your Vote campaign helped register tens of thousands of American Muslims as new voters, ensuring that the voices of the American Muslim community, as a whole, become a vital part of the political process.

The Voice Your Vote campaign reemphasizes CAIR Oklahoma's commitment to community activism and involvement. Oklahoma Muslims have become increasingly concerned with ensuring that their voices are heard by local, state, and national officials. CAIR Oklahoma provides numerous resources in order for Muslims in the state to become educated on various political issues so that they can provide constructive insights on such topics. CAIR Oklahoma also lends itself to support religious minorities and those that are generally disenfranchised within a system in which to become involved on the issues that matter most to their respective communities.

Following the uproar by Muslims worldwide after the release of an appallingly anti-Islamic film was released; CAIR Oklahoma saw the need to quell the divisiveness that had been created by drawing attention to the peaceful and justice-centered principles of Islam and Prophet Muhammad (peace be upon him). Instead of perpetuating the deconstructive and unethical behavior that had led to innocent lives being taken, CAIR Oklahoma acted quickly in reviving a CAIR National campaign that had proven successful in detailing Prophet Muhammad's timeless legacy.

On September 19th, 2012, CAIR Oklahoma kicked-off its *Know the Legacy* campaign offering a free educational DVD to any household in Oklahoma that requested one via CAIR Oklahoma's website or by phone. The campaign, which is ongoing, has surely improved many Oklahomans' knowledge of Prophet Muhammad's inspiring message in an objective and uniting manner.

Developing Tomorrow's Leaders Today

MYLS (Muslim Youth Leαdership Symposium) is a program that CAIR Oklahoma adopted in the Summer of 2009 as a way to train Oklahoma Muslim Youth to become social activists and community leaders. Over the course of 4 years, CAIR Oklahoma has trained over 250 budding youth leaders and community activists through its *MYLS* programs. Heading into its 5th year in 2013, CAIR Oklahoma has plans to expand the *MYLS* program to also include a program geared towards middle- and high-school aged students that will prepare them for college, provide guidance on campus activism, and be a venue for career counseling and development.

The core mission of the Oklahoma MYLS program is to:

- Provide Oklahoma Muslim youth with a proactive agenda for positive activism.
- Empower Oklahoma Muslim youth to guide their communities from the margins to the mainstream.
- Foster a healthy Oklahoma Muslim identity that fits comfortably within a pluralistic American society.

MYLS encourages Oklahoma Muslim youth to proactively define themselves in order to combat the negative perceptions of Islam that have become a part of the mainstream discourse. Through a series of workshops, debates, and collaborations, *MYLS* provides high school seniors and college students with the tools to advance both professionally and spiritually.

Over 40 students from across Oklahoma, Kansas, and Texas attended *MYLS* in 2012, and discussed proactive measures to counter challenges facing the Oklahoma Muslim community. These young individuals participated in workshops and activities that provide them with the tools to make a positive difference in their local communities.

In January 2012, an appeals court in Denver, Colorado, upheld the injunction against *Shariah* law ban in Oklahoma courts. CAIR Oklahoma's executive director at the time, Muneer Awad, and CAIR National attorney, Gadeir Abbas, were present in Denver, CO for the ruling. CAIR Oklahoma sued to block State Question 755, approved by 70 percent of Oklahoma voters on November 2, 2010. State Question 755 bars Oklahoma state courts from considering or using *Sharia law*. CAIR Oklahoma and Muneer Awad contended the measure stigmatizes those who adhere to the Islamic faith, limits the results Oklahoma Muslims can obtain from the courts and would prevent Awad's last will and testament from being probated in Oklahoma because his will has references to *Shariah law*. The appellate judges concluded the amendment "would disfavor (only) his religion," in violate of the U.S. Constitution's provision stating, "Congress shall make no law respecting an establishment of religion." This decision is an important reminder that the Constitution is the last line of defense against a rising tide of anti-Muslim bigotry and Islamophobia in our society.

Although the injunction brought against Oklahoma's State Question 755 was a victory for religious freedom in Oklahoma, the fight to protect the religious rights of Oklahoma Muslims is far from over. CAIR Oklahoma, along with partner organizations such as the ACLU of Oklahoma, continues to monitor any possible anti-Islam or anti-Muslim legislation that could infringe on the rights of Oklahoma Muslims to freely practice their faith according to the rights provided forth in the United States Constitution.

After taking over for Muneer Awad as executive director in July 2012, Adam Soltani took over the reigns of the opposition to *anti-Shariah* measures in the state of Oklahoma. "We will not rest until the constitutional rights of Oklahoma Muslims, and all Oklahomans, are upheld," said Adam Soltani, "Our country was founded upon the principles of religious freedom, we owe it to our founding fathers to uphold these ideals." "CAIR Oklahoma is a stalwart defender of the innate dignity of the human person and an integral protector of our democracy and secular society. The work that they do allow for all to participate in society out of the depths of their faith tradition all while insuring that no one voice overpowers the rest. I, for one, am glad to know that they are at work in our state as they effort to shine light into the darkness of oppression and marginalization. The work they do make me proud to be an Okie and give me hope as I raise my child in this state."

Protecting Our Houses of Worship

On August 12, 2012 at 2:45 AM, vandals pulled into the parking lot of the Grand Mosque of Oklahoma City and fired several rounds of paintballs at the mosque's doors. Imam Imad Enchassi, Imam of the Islamic Society of Greater Oklahoma City, reminded Oklahomans of Islam's peaceful nature by stating, "It is hard to believe that there are still individuals that would commit such an act of hate. As Oklahoma Muslims, we keep our mosque doors open to the public and our arms and hearts are always open to those who want to learn about Islam. We believe that lack of information is what leads to acts such as this one." CAIR Oklahoma immediately called on state and federal law enforcement authorities to investigate the attack as a potential hate crime.

CAIR Oklahoma Executive Director Adam Soltani emphasized the need for religious tolerance and awareness by noting, "The growing number of these attacks should be of concern to national religious and political leaders who have an important role to play in challenging the rising level of anti-Muslim rhetoric in our society, and particularly Islamophobic rhetoric coming from the right-wing of the political spectrum." By highlighting the Islamophobic atmosphere that is, unfortunately, still present in our state, Soltani echoed one of CAIR Oklahoma's core values- protecting the freedom of religion for every Oklahoman. As an organization, CAIR Oklahoma is dedicated to not only securing rights for Muslims, but members of all faith communities in Oklahoma. This hate crime served as a reminder that interfaith dialogue must continue, despite adversity, as mutual understanding is key to protecting all of Oklahoma's houses of worship.

Additionally, as a response to this and other incidents around the country, CAIR Oklahoma developed a *Community Safety Guide* to help protect against anti-Muslim bigotry and to protect constitutional rights. By taking the opportunity to develop new literature on the importance of keeping faith communities safe, CAIR Oklahoma's progressive response to the vandalism of an Oklahoma mosque should not be minimized. The *Community Safety Guide* reminds Oklahoma Muslims to build strong relationships with neighbors of each mosque and to hold community meetings in order to discuss issues present in their respective communities.

"In spite of attacks on minority religious institutions, it is still important for our Country and our Constitution that 'religious freedom' continues being a gift for every citizen, whether Muslim or anyone else. Over all diversity has served this Country and our State of Oklahoma well. CAIR Oklahoma has been one of those who has confronted 'the majority' and not backed down. That helps make my home in Oklahoma a better place to live and I am proud of that."




